**Government Order No. 04 -JK (Agri) of 2020
Dated : 01 -01- 2020**

In the interest of administration, the following transfers and postings of I/c Agriculture Officers are hereby ordered with immediate effect:

1. Sh. Omkar Singh Chowdhary I/c CAO Reasi is transferred and posted as I/c Agriculture Chemist Jammu against the available vacancy.
2. Sh. Iqbal Singh I/c Floriculture Development Officer Srinagar is transferred and posted as I/c CAO Reasi vice Sh. Omkar Singh Chowdhary.
3. Sh. Ravinder Thaploo I/c Deputy Director (Central) Agriculture Department Jammu is transferred and posted as I/c Project Officer Soil and Water Management Command Area Development Department Jammu vice Sh. Jagmohan Bhat .
4. Sh. Jagmohan Bhat I/c Project Officer Soil and water Management Command Area Development Department Jammu is transferred and posted as I/c Deputy Director (Central) Agriculture Department Jammu.

Further in view of an administrative exigency and in order to ensure smooth functioning of the department, the following temporary arrangements are made:

5. Mrs. Daisy Bhan I/c DSSO Jammu shall also look after the charge of the post of Joint Director State land Use Board in addition to her own duties.
6. Sh. Omkar Singh Chowdhary I/c Agriculture Chemist Jammu shall also look after the charge of the post of Joint Director Agriculture (Extension) Jammu in addition to his own duties.

7. Sh. Anil Kumar Nargotra I/c CAO/equivalent rank officer looking after the charge of Agriculture Research Engineer Jammu shall also look after the charge of the post of Joint Director Agriculture (Inputs) Jammu in addition to his own duties.

The above arrangements from S.No. 5 to 7 shall be:

- a) Purely temporary for a period of 03 months in respect of S.No. 5 and 7 and for a period of 2 months in respect of S.No. 6 or till these posts are filled up under rules by DPC/PSC; whichever is earlier.
- b) Not confer any right or superior claim in favour of these officers for regularization and shall be without prejudice to the outcome of any writ petition(s) pending consideration before any competent court(s).
- c) Reversible without any prior notice to any officer(s) in whose case any adverse report/remarks are received from any organization/agency.
