- 4. Dependent Certificate issued bv the **Assistant** Commissioner, (Revenue) concerned.
- 5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
- 6. Any other certificate as required under Rules;

Besides the above, if on verification, any of the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Sericulture Development Department, J&K, Jammu.
