**Subject: Constitution of Enquiry Committee.**

**Government Order No. 103 -Agri of 2017**  
**D a t e d 29 -03-2017**

Whereas, the Department have received various corruption complaints against Sh. M.Y.Masoodi, I/c Dy. Director Law Enforcement, Agriculture Department, Lal Mandi, Srinagar from GAD(Vigilance), CM Secretariat, J&K and Crime Branch, J&K, Srinagar, vide letter dt: 20.12.2016, dt: 14.06.2016 and dt: 24.10.2016 respectively regarding corruption and misuse of official position;

Whereas, the complaint has been examined and Director Agriculture Kashmir vide this Department's letter No. Agri/Gaz/Compt/67/2015 dt: 03.12.2015 has been requested to furnish factual report in the matter in a time bound manner;

Whereas, despite repeated reminders issued on 31.05.2016, 02.12.2016 and 30.06.2016, the Director Agriculture Kashmir has submitted factual report vide letter dated: 17.02.2017, which is as under:-

“As per the procedure in vogue, complaints referred to Directorate are sent to DVO for enquiry and accordingly all the complaints referred to Directorate were forwarded to him for an indepth enquiry/ report vide No. Agri/CTO/2016-17/356 dt: 17.10.2016. However, the said officer has also failed to conduct enquiry into allegations leveled against the accused. After assessing the ground level situation, DAK is of the opinion that holding of any enquiry against the accused by an officer of Agriculture fraternity will lead to biased results and as such any impartial enquiry will be difficult/veracity will not be ascertained in the case.

In view of above referred circumstances and that the matter is directly related to the welfare of the farming community, it is proposed that a team of officers from Administrative Department be constituted to enquire about allegations leveled against him.”

Whereas, keeping in view of the above report, the matter has again been examined and it has been decided that an Enquiry Committee be constituted for conducting in-depth enquiry into the allegations of the complaint;

Now, therefore, Committee of following officers is hereby constituted to enquire into the matter of complaint/allegations in depth against Sh. M.Y.Masoodi, Ex-I/c Deputy Director Law Enforcement :-
