Sanction is hereby accorded to the temporary appointment of Mr. Raj Kumar S/o Late Mr. Chuni Lal (Ex-Nursery Man) R/o Bandrali, Tehsil Bishnah, District Jammu, as Class-IV (Orderly), in the Pay Band of Rs.4440-7440 with the Grade Pay of Rs.1300/- in the Sericulture Development Department in District Cadre Samba, in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director Sericulture Development Department, J&K Jammu within a period of 21 days from the date of receipt of this Order failing which his appointment shall be deemed to have been cancelled ab-initio without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to the appointee unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Sericulture Development Department, J&K, Jammu.


