Sanction is hereby accorded to the temporary appointment of Ms. Kamlesh Kumari D/o Late Krishan Lal (Ex-Helper) R/o Village/Post office Chakrohi, Tehsil Chakrohi (Suchetgarh) District Jammu, as Class-IV (Mali) in the Pay Level SL1 Rs. 14800-47100 in Seed Multiplication Farm, Chakrohi, in District Cadre Jammu, in relaxation of the prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director, Agriculture, Jammu within a period of 21 days from the date of receipt of this Order. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled *ab-initio*, without any further notice. The appointee shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.

5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment office;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Jammu.
