- g) The Executing Agency shall incur expenditure strictly as per works/schemes approved under CAPEX 2019-2020, terms and conditions of authorization and other instructions issued from time to time.
- h) The balance funds under the CAPEX for the FY 2019-2020 shall be released only after Accountant General's Office issues clearance for the funds released so far on this account.
