Sanction is hereby accorded to the temporary appointment of Mr. Reyaz Ahmad Wani S/o Late Ab. Ahad Wani (ex-Helper) R/o Bulgam Tehsil Sopore, District Baramulla as Class-IV (Orderly), in the Pay Band of Rs. 4,440-7,440 with the Grade Pay of Rs.1300 (pre-revised) in the Sericulture Development Department in District Baramulla, in relaxation of prescribed qualification, in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Director General, Sericulture Development Department, J&K, Srinagar within a period of 21 days from the date of receipt of this order. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

- 1. Education Qualification Certificate;
- 2. Age and Health Certificate:
- Permanent Resident Certificate;
- 4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
- 5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
- 6. Any other certificate as required under Rules;



Besides the above, if on verification, the certificates produced by the pointee are proved to be fake or forged, the appointment shall be cancelled b-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director General, Sericulture Development Department, J&K, Srinagar.

It is further ordered that the post of helper held by the deceased is abolished in terms of standing orders issued by the Government, in this behalf.
