Sanction is hereby accorded to the temporary appointment of Mst. Firdousa Akhter, W/o Late Mr. Jehangir Ahmad Mir (Ex-Helper), R/o Sona Masjid, Fateh Kadal, Srinagar as Class-IV (Laboratory Attendant), in the Pay Level SL-1 Rs. 14800-47100 in the office of Mushroom Specialist Srinagar, in relaxation of the prescribed qualification in terms of Rule-7 of SRO 43 of 1994.

The appointee shall report to the Director, Agriculture, Kashmir within a period of 21 days from the date of issuance of this Order. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled *ab-initio* without any further notice. She shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Kashmir.
