Sanction is accorded to the withdrawal of a sum of Rs. 47,52,600/- (Rupees forty seven lakh fifty two thousand six hundred only) along with sanction to the advance drawal of the same amount by the Director Finance, Agriculture Production Department and its placement at disposal of Managing Director J&K State Agro Industries Development Corporation Ltd. for payment to the ex. employees of the Corporation on account of differential amount of COLA, subject to following conditions:-

1. Managing Director, J&K Agro Industries Development Corporation Ltd. shall certify that other cases except the ones put up are pending on this account with the Corporation.
2. Payment released shall be made by the Corporation subject to verification of genuine claims in each individual case;
3. The payment shall be staggered over a two year period starting from July, 2015-16, in installments;
4. This authority is issued in full and final settlement of outstanding claims on this account.
