The regularization order of the Daily Rated Workers shall be issued by the Director, Agriculture, Kashmir subject to the fulfillment of following terms and conditions:-

- a. That he/she is a Permanent Resident of the State of Jammu and Kashmir;
- b. That on the date of his/her initial appointment, his/her age must be within the minimum and maximum age limit as prescribed for appointment in Government service;
- c. That he/she is not a retiree from any State or Central Government service or any Local Body, Public Sector Undertakings or Autonomous Body in or outside the State;
- d. That the Department shall verify records/MRs of first ten months of the incumbents to establish genuineness of the claim.

- e. That the genuineness of engagement order is certified by the HoD concerned.
- f. That the department shall get breaks, if any, other than those certified and verified by the department to be due to non-availability of budget, condoned from the Competent Authority and the breaks subsequent to the date of regularization, if any, shall be seen and verified by the department and no arrears of salary shall be drawn for the period wages have not been paid.
- g. That his/her work and conduct has remained satisfactory during the period he/she worked as Daily Rated Worker and no disciplinary proceedings are pending against him/her;
- h. That he/she has continuously worked in the Department prior to 31/03/1994 till date and fully qualify as per SRO-64 of 1994;
- i. That no departmental enquiry or criminal proceedings are pending against the incumbent and nothing adverse is reported against his/her character and antecedents from the concerned agencies;
- j. That the incumbent fulfils all the terms and conditions as laid down in SRO 64 of 1994 and record note of empowerment committee in Finance Department held on 04-04-2018 endorsed vide No. A/54(2015)-I-200 dated 31-05-2018.
- k. That the Director Agriculture, Kashmir shall ensure that eligibility criteria for regularization as per SRO-64 of 1994 is strictly adhered to and complete original record and bio-data is verified in respect of DRW;
- l. That the posts so created shall not be utilized except for the purpose for which it has been created;
- m. That the posts so created shall cease to exist as and when the existing incumbents vacate the post by way of termination/ retirement/ death/ resignation/ placement against a substantive post/promotion. The Budget

provisions under the wage component shall be correspondingly reduced in the current year's Budget of the Directorate;

- n. That the utilization certificate of the posts approved shall be made available to the administrative department within one month from the date of issue of this order;
- o. That any case involving relaxation in age/qualification bar should be established by the Director Agriculture, Kashmir and referred to the competent authority through administrative department for further necessary action;
- p. That in case of death of the incumbent(s), the post shall cease from the date following the date of death;
- q. That the arrears from the date of regularization to the date of issue of regularization order shall be paid in five (05) equal annual instalments after projecting the same under Annual Budget Estimates of the Department;
- r. That the authenticity of all the certificates shall be established from the concerned department/organization and in case, if any of the certificates is found false or forged, the appointment by regularization shall be cancelled ab-initio.

Further, in view of the urgency, all the members of the deputation are allowed to travel by a low cost air service.


