Sanction is hereby accorded to the temporary appointment of Mr. Ashfaq Ahmad Dar S/o Late Gh. Mohd Dar (Ex-Helper-Cum-Chowkidar) R/o Tamiloo Tehsil & District Kulgam as class-IV (Chowkidar) in the pay Level SL-1 (14800-47100) in the Agriculture Production Department, District Cadre Kulgam, in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director, Agriculture, Kashmir within a period of 21 days from the date of issuance of this order. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

1. Education qualification Certificate.
2. Age and Health Certificate.
3. Permanent Resident Certificate.
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department.
6. Any other certificate as required under Rules.

Besides, the above, if on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character

and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Kashmir.
