Sanction is hereby accorded to the temporary appointment of **Mr. Abid Ahmad S/o Late Abdul Hamid Gojri (Ex-Boiler Attendant) R/o. Allochi Bagh, Tehsil & District Srinagar** as Class-IV (Orderly), in the pay level SL1 Rs.14800-47100 in the Sericulture Development Department, in Divisional Cadre, Kashmir in relaxation of the prescribed qualification, in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director Sericulture Development Department, J&K, within a period of 21 days from the date of issuance of this order. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director General, Sericulture Development Department, J&K, Srinagar.
