The deputation shall, inter-alia, be subject to the following conditions:-

- 1.The selected candidates will execute an agreement/bond with the concerned Head of the Department, undertaking therein that they will serve the Department at least for eight (08) year's after completion of the said course.
- 2.On completion of the course of the study, the Government servant shall submit to the Administrative Department, the certificate of examination passed or special course of study undertaken indicating the date of commencement and termination of the course. Certificate shall be submitted through the concerned authorities of the Sher-I-Kashmir University of Agriculture Science & Technology, Jammu/Kashmir.
- 3.The Head of the Department shall submit a copy of relieving order to the Administrative Department; and
- 4.The said course will not confer any right for preferential claim for their out of turn promotion or any other claim in contravention of rules.


