Subject: - Arrangement for supply of Agriculture Machinery/Equipment and other allied inputs to Departments.


Government Order No. 196 -JK(Agri) of 2020

Dated : 29 - 10- 2020

Sanction is hereby accorded to the arrangement of machinery/equipment and other allied inputs for departmental use by the Agro Industries Development Corporation Ltd. (AIDCL) to the Department of Agriculture, Jammu/Kashmir, Command Area, Jammu, Command Area, Kashmir and Sericulture, J&K, under various scheme/s:-

The broad outlines of this arrangement shall be as under:-

- (1) That the Corporation shall arrange the required machinery/equipment and other allied items from the principal manufactures/ their authorized distributors/dealers as per requirement of the indenting departments.
- (2) The supply of the machinery/equipment should be only of branded items with ISI/BIS marking.
- (3) The departments shall place the indent of the machinery/equipment and other allied inputs for departmental use under various schemes as per the availability of the budget and shall follow the standard procedures of purchase as per laid down framework/rules within the ambit of scheme/schemes and no liability shall be created, whatsoever.
- (4) The Corporation shall ensure supply to the indenting departments/directorates within shortest possible time after indent is placed with the Corporation.
- (5) The Department shall pass on the funds to the Agro Industries Development Corporation Ltd. only after the

- machinery/equipment is being made available within the stipulated time as per the terms of reference of the indent.
- (6) This order shall be reviewed after examining the efficacy of such arrangements in ensuring timely supply at rates lesser than the Departments procuring directly.


