Whereas, vide Govt. Order No. 10-JK(Agri) of 2020 dated 17.01.2020, an enquiry committee comprising of Shri A. R. Samoon, I/C Director Law Enforcement and Shri Syed Aleem Ahmad Faheem, I/C Deputy Director Command Area Development Department Kashmir was constituted to enquire into the alleged irregularities at Seed Multiplication Farm Padgampora; and

2. Whereas, the committee was entrusted to thoroughly enquire into the matter particularly for the last 06 years viz-a viz Production per Unit Area and Inputs applied during the period and also to scrutinize the role of officers/ officials posted in SM Farm Padgampora viz a viz irregularities committed if any at SM Farm; and

3. Whereas, the enquiry committee, vide communication No. Agri/DLE/Estt/2020-21/8-A dated 30.09.2020, submitted its report; and

4. Whereas, the report of the enquiry committee was examined in the department and it was found that the enquiry committee has only recommended measures to be taken and has not pointed out the names of the officers/ officials involved in the irregularities at SM Farm Padgampora; and

5. Whereas, it has been decided to appoint an Enquiry Officer into the matter; and

Now, therefore, Shri Imtiyaz Ahmad Wani, Director Finance, Animal & Sheep Husbandry Department with Additional Charge of Agriculture Production & Farmer's Welfare Department is hereby appointed as an enquiry officer, who shall come up with specific recommendations. The Enquiry Officer shall also identify the officers/officials responsible for lapses and fix responsibility specifying the loss occurring to the Government Exchequer. The Enquiry Officer shall furnish his report/ recommendations to the Government within a period of 15 days.
