Whereas, S. Kulbir Singh Draftsman, borne on the establishment of Agriculture Department, Jammu was deputed to Command Area Development vide Director of Agriculture, Jammu order No. 233/E of 1995 dated 16.09.1995; and

Whereas, in pursuance to above order, S. Kuibir Singh joined Command Area Development, Jammu as Draftsman and was subsequently promoted as Junior Engineer there, vide Command Area Development, Jammu Order No. CAD/Adm/2005-06/PF/926-27 dated 16-09-2005 & the grade of Junior Engineer was released in his favour vide Order No. 81/E of 2006 dated 27-05-2006, although borne on the establishment of Directorate of Agriculture, Jammu; and

Whereas, after discharging his duties in Command Area Development, Jammu for more than two decades, S. Kulbir Singh, Junior Engineer approached to Director Command Area Development, Jammu for fixing his seniority in the Seniority list of Junior Engineers of Command Area Development; and

Whereas, Director Command Area Development, Jammu forwarded the case of S. Kulbir Singh, Jr. Engineer to Agriculture Production Department requesting therein for according necessary approval for shifting his lien/seniority & promotional prospects to CAD, Jammu so that his seniority could be fixed in the Command Area Development Department; and

Whereas, the matter was examined in the department and was accordingly taken up with Director, Agriculture, Jammu who intimated that the name of the official has been dropped from the seniority list of Draftsman, issued by Directorate of Agriculture, Jammu and conveyed his No Objection for fixing the seniority of S.Kulbir Singh, in Command Area Development Department vide Communication No. Agri/DAJ/Estt/2012/5933 dated 01-01-2013, No. Agri/DAJ/Estt--77/CAD/2018/8863 dated 24-11-2018, No. Agri/DAJ/Estt-77/CAD/2018/10932 dated 24-01-2019 and No. Agri/DAJ/Estt-77/2019/4325 dated 15-10-2019; and

Whereas, the said official has been continuously working in the Command Area Development, Jammu for more than Twenty Four Years and has also been promoted in the said organization in the year 2005; and

Now, therefore, in light of above facts and keeping in view the circumstances of the case being a *fait-accompli*, sanction is hereby accorded for shifting of lien in favour of S. Kulbir Singh, Draftsman from Directorate of Agriculture, Jammu to Command Area Development, Jammu from the date the official joined Command Area Department, Jammu i.e. 16-09-1995. His seniority be fixed in the said department under the relevant rules.
