Whereas, vide Government Order No. 215-Agri of 2015 dated 27/07/2015 Shri Abdul Rehman Bhat, the then I/c Deputy Director, Sericulture Budgam was placed under suspension for reasons mentioned there-in with effect from 23/07/2015 in terms of Rule, 31(2) of the J&K Civil Service (Classification, Control and Appeal) Rules, 1956, for having remained in police custody for more than 48 hours; and

Whereas, after his release vide Government Order No. 322-Agri of 2015 dated 13/10/2015 the said officer was attached in the Office of the Additional Director (Sericulture) Kashmir till further orders; and

Whereas, sanction for prosecution of the officer was also accorded by the General Administration Department (Vigilance) vide Government Order No. 39-GAD (Vig) of 2017 dated 11/07/2017; and

Whereas, subsequently, the instant case was referred to the General Administration Department vide this department's U.O.No. Agri/Seri/56/2015 dated 04/08/2017 for its placement before the Review Committee with regard to the reinstatement of Sh. Abdul Rehman Bhat, the then I/c Deputy Director Sericulture, Budgam; and

Whereas, the General Administration Department vide U.O.No.GAD(Vig)19-SP/2017-II dated 02/01/2018 returned the departmental file with the remarks that the suspension case of Sh. Abdul Rehman Bhat, the then I/C Deputy Director, Sericulture Budgam was placed before the Review Committee which was held on 20/12/2017, and the General Administration Department vide Minutes of the Review Committee meeting issued under endorsement No. GAD(Vig)26-Adm/2010-11 dated 29.12.2017 has accordingly

forwarded the Minutes/decision/recommendations of the Review Committee, inter-alia, to this department which reads as under:-

".....to re-instate the officer with the condition that his period of suspension shall be decided after conclusion of the trial, but he should not be assigned any sensitive posting".

Whereas, the case has accordingly been processed in the department and decided to implement the recommendations of the Review Committee.

Now, therefore, in pursuance of recommendations of the Review Committee, Shri Abdul Rehman Bhat, the then I/c Deputy Director, Sericulture Budgam presently attached in the office of the Additional Director, Kashmir is hereby re-instated with immediate effect. His suspension period shall be decided after conclusion of the trial.


