Sanction is hereby accorded to the temporary appointment of Smt. Noor Jahan, Wd/o Late Shri Ali Mohd, R/o Kandi, Tehsil Koternaka District Rajouri on compassionate grounds against a Class-IV Post (Mali) in the pay scale of Rs 4440-7440+1300 (Pre-Revised), Revised Pay Level (SL 1) Rs 14800-47100 in the Agriculture Department in District Cadre Rajouri, in relaxation of the prescribed qualification bar, in terms of Rule 7 of SRO-43 of 1994.

The appointee shall report to the Director, Agriculture, Jammu within a period of 21 days from the date of receipt of this Order. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled *ab-initio* without any further notice. She shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Jammu.


