The release of funds shall be subject to the following conditions:-

1. The HoDs shall ensure that project-wise accounts are maintained and are subject to normal process of statutory Audit, an inventory of the assets created under the projects be preserved and assets that are no longer required shall be transferred to the Nodal department for its use and re-deployment, wherever possible.
2. The HODs/Departments shall implement the programme/ activities/components on the cost norms/guidelines/subsidy component

- at par, which are admissible/ permissible as per the norms of Centrally Sponsored Scheme Sub Mission on Agriculture Mechanization(SMAM).
3. The drawing and disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending.
 4. The HODs shall restrict the expenditure to the actual availability of funds and **no liability shall be created in any case.**
 5. The expenditure shall be incurred only after observing all codal formalities.
 6. The Department shall ensure that there is no overlapping/duplication in adoption of schemes/incurred of expenditure from any other scheme of the State or Central Govt.
 7. The HoDs shall furnish progress (both physical and financial) alongwith Utilization Certificate to the Nodal Officer and after consolidation Nodal officer shall furnish the same to the Administrative Department **by or before 31-03-2017** for its submission to Govt. of India.
 8. The Director Finance/FA/CAO/AO of the Department shall vouchsafe the utilization of the funds as per the procedure/guidelines of the Govt. of India.


