Sanction is hereby accorded to the temporary appointment of Sh. Hoshiyar Singh S/O Late Munshi Ram (Ex-Gardner-Cum-operator) R/O Latyar, Panchari Tehsil & District Udhampur, as Class-IV (Mali), in the Pay Level-SL 1(14800-47100) in the Agriculture Department in District Cadre Udhampur, in relaxation of the prescribed qualification in terms of Rule-7 under SRO 43 of 1994.

The appointee shall report to the Director, Agriculture, Jammu within a period of 21 days from the date of receipt of this Order. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio, without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Jammu.
