Ex-Post-facto sanction is hereby accorded in relaxation of Jammu and Kashmir Civil Services (Medical Attendance-Cum-Allowance) Rule, 1990, to the reimbursement of medical expenses in favour of Mr. Sheikh Manzoor Ahmad, I/C SDAO Ganderbal Agriculture Production Department for treatment of his son namely Mr. Sheikh Zuhaib (expired) at Tata Memorial Hospital Mumbai and Rajiv Gandhi Cancer Institute New Delhi, subject to the following conditions: -

- a) The reimbursement upto Rs. 5.00 Lakhs shall be sought from the concerned Medical Insurance Company, if the Officer is insured under Mediclaim Insurance Policy.
- b) The reimbursement of charges is restricted to items/procedures admissible under rules for the period of Hospitalization (w.e.f 31.07.2017 to 08.08.2017 at Tata Memorial Hospital, Mumbai and w.e.f 19.09.2017 to 16.10.2017 & 21.10.2017 to 29.11.2017 at Rajiv Gandhi Cancer Institute and research Centre, New Delhi and cost thereof is restricted to the extent of rates applicable to such items /procedures at AIIMS, Delhi.
- c) All the relevant medical vouchers/bills are verified and countersigned by the competent medical authority.
- d) Essentiality certificate of the hospital where treatment has been undertaken is obtained.
- e) All the Codal formalities are observed before incurring expenditure

This issues with the concurrence of Finance Department Vide their U.O No. A/13(2008)-477, dated 23-05-2018 and sanction of General Administration Department issued Vide O.M No. GDC-119/CM/2018, dated 27-08-2018.


