Sanction is hereby accorded to the temporary appointment of Mr. Mohd Ramzan Dar S/o Late Gh. Mohammad Dar (Ex-Rakha) R/o Palhallan Ghat, Tehsil Pattan, District Baramulla against Class-IV post (Chowkidar) in the Pay Level (SL1) Rs. 14800-47100 in Agriculture Department Kashmir, in relaxation of the prescribed qualification bar in terms of Rule 7 of SRO-43 of 1994.

The appointee shall report to the Director, Agriculture, Kashmir within a period of 21 days from the date of issue of this Order. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled *ab-initio* without any further notice. He shall be allowed to join only on production of the following documents/certificates in original:-

1. Education Qualification Certificate;
2. Age and Health Certificate;
3. Permanent Resident Certificate;
4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.
5. No Loan Certificate under Self Employment Scheme from DIC and concerned Employment Department;
6. Any other certificate as required under Rules;

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled *ab-initio*.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Agriculture Kashmir.


