- 4. Dependent Certificate issued by the Assistant Commissioner, (Revenue) concerned.

Besides the above, if on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Sericulture Development Department, J&K, Jammu.
