Sanction is accorded to the release of additionality of **₹.100.00 lac** (Rupees One crore only) out of CAPEX Budget 2016-17 in favour of Director Finance, Agriculture Production Department for procurement of Mushkibudji Rice from farmers and marketing thereof by Agros Industries Development Corporation Limited (AIDCL) along with advance drawal by the Director Finance, Agriculture Production Department for placement of funds at the disposal of Managing Director, J&K State Agro Industries Development Corporation Ltd. (AIDCL).

The sanction is subject to the following conditions:-

1. The Managing Director, AIDCL shall devise a mechanism for procurement of Mushkibudji Rice from farmers and marketing thereof in terms of Government Order No.297-Agri of 2016 dated 15-12-2016;
2. The funds are released to the Managing Director, AIDCL as market intervention support, as a revolving fund and shall be recouped from AGROs in two equal instalment in the next two years;
3. The Managing Director, AIDCL shall regulate the funds in accordance with the mechanism devised by the Planning, Development and Monitoring Department in Government Order No.309-PD of 2016 dated 17-11-2016.
4. The Managing Director, AIDCL shall incur expenditure only after completion of all codal procedures/formalities;

5. The Managing Director, AIDCL shall ensure submission of Monthly/ Quarterly progress Reports (physical and financial) as per GNO and GN2 to Adm. Department latest by 3rd of every month/quarter positively for its submission to Planning and Development Department by 5th of every month;
6. No re-appropriation /Diversion/retention of money is allowed in any case;
7. Third Party monitoring and convergence of the scheme be ensured;
8. Other condition as mentioned in Government order No.269-Agri of 2016 dated 23-11-2016 issued by Agriculture Production Department shall be adhered strictly;
9. The funds shall be debited to the following head of Accounts:
