The appointees shall report to the Director, Agriculture Jammu within a period of 21 days from the date of issue of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- Academic Qualification Certificate.
- Date of birth Certificate.
- Permanent Resident Certificate
- Category Certificate, if any.
- Fitness/Health Certificate
- No loan certificate under self employment scheme fund from DIC concerned and Employment Department.
- Affidavit dully attested by the 1st Class Magistrate, the certificates produced by the appointee prove to be fake forged; the department is legible to take any action under court of law.

The appointment shall be subject to the outcome of writ petition(s) pending in any court of the competent jurisdiction.

The appointees shall initially be on probation for a period of five years and after completion of five years their services shall be declared as temporary permanent interms of SRO-202 of 2015 dated 30.06.2015.

If on verification, any of the certificates produced by the appointees proves to be fake or forged, the appointment shall stand cancelled ab-intio.

During the period of probation, the appointees shall be entitled to the minimum scale of pay applicable to the post against which the candidates are appointed interms of SRO-202 of 2015 dated 30.06.2015

The salary of the appointees shall not be disbursed to them unless a satisfactory report about their character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director Agriculture Jammu.


