**Subject: Advance Drawal of Rs.1000.00 lacs (Rupees Ten crore) under
Market Intervention Scheme (MIS) Under Capex Budget-
2015-16**

**Government Order No: 353 – Agri. of 2015
Dated: 17-11-2015**

Sanction is hereby accorded to the advance drawal of Rs. 1000.00 lacs (Rupees ten crore) only under Capex Budget 2015-16 in favour of Director Horticulture(Planning and Marketing), Jammu and Kashmir, for the implementation of the Market Intervention Scheme (MIS) for procurement of C-Grade apple from growers of the State during the year 2015-16 in Sopore division (Baramulla District), Shopian Tehsil (Shopain District) and Dachnipora zones (Anantnag District) released vide Government Order No. 319-Agri of 2015 dated 09-10-2015 subject to the following conditions.:-

- a) The amount so released shall be utilized as per the conditions and guidelines issued vide Government Order No: 317 Agri 2015, Dated: 09.10.2015;
- b) No re-appropriation /Diversion/retention of money is allowed in any case;
- c) All Codal procedure be followed before incurring expenditure;
- d) The instructions of Circular No. 3-PD of 2015 dated 15.06.2015 of Planning and Development Department conveyed vide this Department Letter No. Agri/PC-17/2014-15 dated 17.06.2015 shall be adhered to;
- e) Director Finance Agriculture Production Department and Accounts Officer of Directorate of Horticulture, Planning and Marketing shall vouchsafe availability of funds for the purpose and expenditure shall be incurred after fulfilment of all codal formalities;
- f) Utilisation certificate of the amount be sublimed to the concerned quarters well in time;
- g) The expenditure should be booked as per the relevant head of account; and
- h) The drawal will be as per the fruit procurement and on need basis.

This issues with the agreement of the Finance Department vide their U.O. No. FD-VII-12(98)Agri/ 2003 dated 09.11.2015.
