

The terms of reference for the sub-committee shall be as under:-

- i. To examine the DPRs of the proposed projects as per the revised guidelines of the MIDH;
- ii. To examine all new and pending projects in the Directorate of Horticulture which were part of Mission Programme of HMNEH and MIDH as the schemes of HMNEH were sub-summed under MIDH with little modification to integrate the plan implementation;
- iii. To ascertain the feasibility and economic viability of the [project neither access capacity nor under capacity of the projects should take place and should commensurate with the potential of the area where the project will be established. Site inspection may also be made; and
- iv. The Committee shall also consider any other issue relevant to the subject, as may be referred to the committee.



The committee shall take decision on all pending cases within a period of ten (10) days for the issuance of this order.
