**The release of funds is subject to the following conditions:-**

- The amount released shall be available for the ongoing projects Sanctioned by NABARD under RIDF XIX,XX,XXI,XXII to XXII.
- The HoDs shall ensure that no diversion shall be made towards any other scheme and none of the schemes is funded from any other sources of finance except for State share;
- The HoDs shall utilize the funds after observing all codal formalities/procedures as required under rules including AAA and Technical Sanction and in consonance with the NABARD Guideline;
- The drawing and disbursing officers shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- The HoDs shall ensure that there is no overlapping/ duplication in adoption of scheme/ incurring of expenditure from any other scheme of the State/ Central Govt. except for state share;
- The HoDs shall utilize proportionate state share earmarked for the projects simultaneously during 2018-19;
- The HoDs shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case;



- viii) The HoDs shall submit Project-wise UCs ending March,2019 to the department by or before 10<sup>th</sup> of April,2019;and  
ix) The HoDs shall submit Project-wise details and proper classification on prescribed format of BEAMS at an earliest;


