Sanction is accorded to the release of funds amounting to **₹ 2.00 Crore (Rupees Two Crore only)** during the current financial year 2017-18, in favour of Director Agriculture Jammu under Special Task Force Project for Jammu Division **"Up gradation of Chakroi Seed Multiplication Farm for Jammu Basmati"**.

The release of funds is subject to the following conditions:-

- a) The Director Agriculture Jammu shall execute/implement the works only after completion of all codal formalities/procedures and for the component wherever AAA stands accorded;
- b) The execution of works shall be taken up strictly for " Up gradation of Chakroi Seed Multiplication Farm for Jammu Basmati" under Special Task Force Project and no liability shall be created;
- c) Necessary AAA and Technical sanction(s) shall be obtained/conveyed prior to the execution of works/projects;
- d) A comprehensive exercise shall be carried out to remove duplication/ replication of scheme to ensure completion and consolidation of the project in order to make the project objective oriented;
- e) There shall be no overlapping of funding from any other source. In no case the estimated cost shall exceed the cost adopted by the Special Task Force(STF) for each component;
- f) The further release of funds to the executing agencies shall be affected immediately so as to ensure continuity in the implementation of programmes/ execution of works;

- g) No re-appropriation/ diversion/ retention of money is allowed in any case;
- h) Director Agriculture Jammu shall also furnish the UCs of the released amount.
- i) The expenditure shall be debited to the appropriate Head of Account and Classification of Account (CAPEX Budget).
