**Government Order No. 92 - Agri of 2017
Dated: 22-03-2017**

Sanction is hereby accorded to the release of ₹ 57.71 lacs (fifty seven lac and seventy one thousand only) in favour of Director Agriculture Kashmir (Nodal Officer NeGP-A) for its further placement at the disposal of concerned officers/implementing agencies of the scheme under Centrally Sponsored Scheme, "National e-Governance Plan-Agriculture (NeGP-A)" during 2016-17:-

The sanction is subject to the following conditions:-

- 1) The funds shall be utilized strictly on the approved Work Plan as the case may be on the activities authorized by the Government of India.
- 2) Nodal Officer will ensure proper Physical/Financial monitoring of the project programmes and submit snap verification report;
- 3) The implementing agency shall implement the programme/ activities/ components on the cost norms/guidelines/subsidy component at par, which are admissible/ permissible in the Centrally Sponsored Scheme, "National e-Governance Plan-Agriculture (NeGP-A)" during 2016-17;
- 4) Nodal Officer shall ensure that NeGP-A is implemented for all three departments i.e Agriculture, Horticulture, Animal/Sheep Husbandry and Fisheries hitherto fore;
- 5) The drawing and disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- 6) The expenditure shall be incurred only after observing all codal formalities required under rules;
- 7) The implementing agency shall ensure that there is no overlapping/duplication in adoption of schemes/incurrence of expenditure from any other scheme of the State or Central Government;
- 8) Proper tendering of items and check up of specification by competent authority be ensured before incurring any expenditure this account, if purchase on DGS&D rate structure;
- 9) The implementing agency shall furnish progress (both physical and financial) to the Administrative Department by 31-03-2016 for its submission to Govt. of India;

- 10) Director Agriculture Kashmir (Nodal Officer NeGP-A) shall furnish the release order copy to Administrative Department;
- 11) The Nodal Officer (NeGP-A) shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case;
- 12) The purchase should be made through the purchase committee after getting the approval from the competent authority;
- 13) The Nodal Officer should provide the details regarding plan expenditure and cost sharing and other efficiency gains expected from the scheme;
- 14) All conditions mentioned in the sanction No. Z-11018/43/2016-IT FTS NO.27871 dated 10-01-2017 of Ministry of Agriculture and Farmer's Welfare, Government of India should be adhered to while implementing the programme.
