**Subject: Release of Funds of 2015-16 under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)-one time grant for preparation of District Irrigation Plan (DIP) for its utilization during 2016-17.**

**Dated: 22 - 03- 2017**

In continuation to Government order No.300-Agro of 2016 dated 21-12-2016, sanction is hereby accorded to the release of **Rs. 2.00 lac (Rs two lacs only)** in favour of Director Finance, Agriculture Production Department raising thereby total releases to ₹ 9.00 lacs for meeting the expenditure on account of contingences/ administrative expenses under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)-one time grant for its utilization during 2016-17.

*The release of funds shall be subject to the adherence to the relevant conditions:-*

- 1) The funds shall be utilized for preparation of District Irrigation Plans (DIPs) under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY);
- 2) Mission Director shall ensure that the maximum amount for preparation of DIPs would be restricted to Rs. 10.00 lac or the actual cost whichever is less. Balance amount if any would be refunded/adjusted in the grant to be released for preparation of DIP's for other Districts;
- 3) Mission Director shall ensure that the preparation of District Irrigation Plans (DIPs) should be prepared with all concerned departments for implementation of PMKSY;
- 4) Mission Director shall ensure that the requisite no. of DIPs are prepared under overall supervision of Inter Departmental Working Group (IDWG) constituted as per the operational guidelines of PMKSY;
- 5) The DIPs prepared shall be placed before the State Level Sanctioning Committee for approval by Mission Director` within the stipulated period;
- 6) The funds released is non recurring nature and while booking the expenditure the drawing and disbursing officer(s) should adhered the PMKSY guidelines issued by the Ministry in this behalf;
- 7) The drawing and disbursing officer(s) shall ensure that accounts are maintained and are subject to normal process of statutory audit likewise, an inventory of the assets created under the projects should be carefully preserved and assets that are no longer required

- shall be transferred to the Nodal department for its use and re-deployment where ever possible;
- 8) The drawing and disbursing officer(s) shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
  - 9) The expenditure shall be incurred only after observing all codal formalities required under rules;
  - 10) The drawing and disbursing officer(s) shall ensure that there is no overlapping/duplication in adoption of schemes/incurred of expenditure from any other scheme of the State or Central Government;
  - 11) The Director Finance, Agriculture Production Department shall submit Utilization Certificate by 31-03-2017 along with Physical and Financial progress Reports to the Mission Director PMKSY for its submission to the Government of India;
  - 12) Director Finance/FA/CAO of the Department shall vouch safe the utilization of the funds as per the codal procedures/GoI guidelines.
