5. The DDO shall ensure, before the release of payment, that it is safe, secured and guaranteed. The quality of the supply, after the release of advance payment should conform to the standard specifications and samples received in advance.
6. That the advance payment shall be released against valid irrevocable and confirmed bank guarantee.
