Whereas, the General Administration Department vide communication No.GAD/MTG0RB-IV/63/2021-09-GAD dated 19.10.2021 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide communication No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 pertaining to Agriculture Production and Farmers Welfare Department for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020; and

2. Whereas, the General Administration Department had forwarded the selection list of the candidates to the respective Deputy Commissioners with the request to ensure the filling of their character verification rolls and forward the same to the Director General, CID, J&K, Srinagar for verification of Character and Antecedents of the candidates. The General Administration Department, subsequently, requested all the Deputy Commissioners to forward the verification report in respect of Character and Antecedents of all the selected candidates as received from the Criminal Investigating Department (CID) J&K, directly to the appointing authorities so that the appointment orders of these candidates are issued; and

3. Consequent upon the above, and in continuation to Government No. 173-JK(Agri) of 2021 dated: 22.10.2021, sanction is hereby accorded to the temporary appointment of 34 (thirty four) candidates (Annexure-I and II) as Class-IV, Divisional/District Cadre Jammu/Kashmir in the Agriculture Production and Farmers Welfare Department, in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

4. The appointment of the candidates is subject to fulfillment of the following conditions:-

The appointee(s) shall report to the Administrative Department, Agriculture Production & Farmers Welfare Department, Civil Secretariat, Jammu/Srinagar within a period of 21 days from the date of issuance of this order. If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego his/her right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.

The allocation of the allied departments viz. Agriculture Production and Farmers Welfare, Command Area Development and Sericulture Development to the candidates shown in the annexures of the Government order shall be issued separately.

- a. The appointee(s) shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-
  1. Academic/Technical Qualification Certificates.
  2. Date of Birth Certificate.
  3. Health Certificate issued by Chief Medical Officer.
  4. Domicile Certificate issued by the Competent Authority.
  5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
  6. Reserved Category Certificate (in case of candidates belonging to reserved category).
- b. If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- c. The appointment of the said candidates shall be governed by the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.
- d. The appointment shall be cancelled ab-initio, if it is found that the candidate(s) possess higher qualification than the prescribed one at any stage and he/she shall also be liable for action under law.
- e. The appointee(s) shall be on probation for a period of 02 years.
- f. The inter-se seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.
- g. The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

- g. The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- h. The appointment of the candidates is subject to the outcome of any writ petition(s)/OA pending before any Court of competent Jurisdiction.
- i. In view of the provisional security clearance received from the CID, the appointee(s) shall give an undertaking in the prescribed format forming **Annexure- III** to this order and in the event of any adverse report received from the CID, subsequently, the appointment of the appointee(s) shall be deemed to have been cancelled ab-initio.
