In continuation to Govt order No.32-Agri of 2014 dated 16-07-2014, sanction is accorded to the release of an amount of Rs.18.75 lacs (Rupees Eighteen lacs and seventy five thousand only) as 2<sup>nd</sup> instalment alongwith advance drawal by Director Finance, Agriculture Production Department at Civil Secretariat Treasury and its further placement at the disposal of Managing Director, JKHPMC against the current year's allocation for meeting the expenditure in respect of capital component during 2014-15. The implementation of work plan is subject to the approval by the Board of Management of JKHPMC.

**The sanction is subject to following conditions:-**

- (i) The funds shall be utilized after observing all codal formalities and no diversion of funds is allowed from one object /head to other.
- (ii) The amount is fully vouched for and no diversion/ deviation or retention of the money is allowed.
- (iii) The accounts shall be rendered to Accountant General upon utilization of the released funds.
- (iv) The further releases shall be considered upon furnishing of Utilization Certificate from the Accountant General.
- (v) Only infrastructure development /capital formation projects are allowed.
- (vi) No land acquisition or State Share is allowed.
- (vii) No recurring, maintenance, repairs, renovation etc is allowed.

The expenditure shall be booked under Major Head 4401-Capital outlay on Crop Husbandry—Agri. Investment Crop JKHPMC (Plan).


