6. Reserved Category Certificate (in case of candidates belonging

to reserved category).

- a) If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled abinitio.
- b) The appointment of the said candidates shall be governed by the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.

c) The appointment shall be cancelled ab-initio, if it is found that the candidate(s) possess higher qualification than the prescribed one at any stage and he/she shall also be liable for action under law.

d) The appointee(s) shall be on probation for a period of 02

- e) The inter-se seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.
