b) Purely temporary for a period of six months only to look after the charge of the post till the posts are filled up under rules by DPC/PSC whichever is earlier.

c) Purely treated as a "look after arrangement" for smooth functioning of the department and shall in no case be constituted as order to be followed in a placement of seniority list by way of being in order of arrangement.

d) Not confer any right of superior claim in favour of the officers for regularization and shall be without prejudice to the outcome of any writ petition(s) pending consideration before any competent Courts(s).

e) Reversible without any prior notice to any officer(s) in whose case any adverse report/remarks are received from any organization/agency.
