5. **Liaison and Coordination:** Members will work in close liaison with each other and their respective. They will be responsible for ensuring effective coordination within their domains and across the project implementation spectrum.
6. **Reporting and Monitoring:** Regular reports on project progress and challenges will be submitted by the Core Team through their respective Directors to APD.


