Sanction is hereby granted to the nomination of Dr. Shameem Ahmad Sheikh, Veterinary Assistant Surgeon, Gagrian, District Poonch, Sheep Husbandry Department, Jammu to under go M.V.Sc training course at SKUAST, Kashmir, in the academic session 2024 as in-service candidate, subject to following terms and conditions :-

- i) The study leave shall be governed by general principles laid down in J&K Civil Service (Leave) Rules, 1979 as amended from time to time and other specific instructions issued by the Government from time to time.
- ii) The officer has completed 05 years of service in the Department including 02 years of regular farm duty or rural service.
- iii) The officer has acquired at least 60% marks in aggregate in B.V.Sc with minimum 70% marks in aggregate or equivalent in the discipline for which he is being admitted for M.V.Sc.
- iv) The Officer shall compulsorily render minimum 10 years of service in the Department after completion of M.V.Sc and if for any reason, he leaves the Department before rendering 10 years of service, he shall have to refund pay including all allowances as penalty, which he would have received during study period and any allowance/incentive received by him on acquiring such higher qualification upon completion of the

course, along with interest and other charges as may be determined by the Department.

- v) The Officer before proceeding on study leave but after sanction of leave, shall have to execute an undertaking in the shape of an affidavit duly attested by 1st class Magistrate that after completion of degree, he shall work in the Department atleast for 10 years, failing which shall have refund all the charges as mentioned at condition No. iv. above.
- vi) The Higher qualification attained by the officer shall be treated as additional qualification in the interest of Department but shall not count for promotion benefits including Non functional time bound promotion. The Department reserves the right to with draw this order or add any other conditions as may deem fit.
