Subject: FIR due to threat to life and property - criminal intimidation - with vested interest to grab residential house and property at village Nasirabad, Kulgam.

Government Order No:- 55 -JK(Agri) of 2021

Dated:- 29 .03.2021

Whereas, the department has received a representation from Dr. Syed Basharat Ahmad Shah via electronic mail, leveling serious allegations against Shri Davood Ahmad Shad viz-a-viz threat to life and property criminal intimidation. The complainant had also approached the Hon'ble advisor (F) with the same representation; and


Whereas, the representation was examined in the department and Director Agriculture Kashmir vide this department's letter dated 21.01.2021 was requested to furnish a detailed report in the matter; and

Whereas, in the meanwhile, the department vide Govt. Order No. 21-JK(Agri) of 2021 dated 30.01.2021 transferred Shri Davood Ahmad Shad from Kulgam and assigned him lookafter charge of the post of SDAO-Tangdar; and.

Whereas, another communication bearing NO. PS-CS-2021-383-R dated 02.02.2021 was received from the office of Chief Secretary, J&K in which representation of Ms. Razia Parveen W/O Syed Basharat Ahmad presently living in Germany was forwarded to this department; and

Whereas, in view of the above position, the department vide Govt. order No. 36-JK(Agri) of 2021 dated 17.02.2021 appointed Shri Nazir Ahmad Wani, presently looking after the charge of the post of CAO Kupwara as enquiry officer to conduct enquiry into the allegations leveled against Shri Davood Ahmad Shad by Dr. Syed Basharat Ahmad Shah and counter allegations leveled against the complainant by Ms. Razia Parveen w/o Syed Basharat Ahmad Shah, sister of Davood Ahmad Shad; and

Whereas, the enquiry Officer, Shri Nazir Ahmad Wani, vide communication No. CAO/K/Estt/2020-21/2900-2901 dated 10.03.2021, has submitted the enquiry report, whereunder the Enquiry officer has recommended that Mr. Davood Ahmad Shad, SMS-III may be exempted

/exonerated from charges leveled against him by his brother in Law, being purely a family dispute; and

Whereas, the enquiry officer, in his report has submitted that the allegations leveled against Mr. Davood Ahmad Shad, SMS-III do contradict with the complaint made by Dr. Syed Basharat Ahmad on 12.01.2021. Besides, that the statements received from different sources and through mail of Ms Razia parveen W/O Dr. Syed Basharat Ahmad do reveal non involvement of Davood Ahmad Shad, SMS-III in any theft or life threat against the complainant namely Dr. Syed Basharat Ahmad; and

Whereas, Director Agriculture Kashmir vide Communication No. Agri/Estt/Gaz-complaint/2020-21/4405 dated 16.02.2021 also reported that Dawood Ahmad Shad is a hardworking, dedicated and punctual to his legitimate duties as such the case may be considered accordingly and charges leveled against the officer be withdrawan; and

Whereas, the matter was further examined in the department and it has been decided to accept the recommendations of the enquiry officer and close the enquiry initiated against the officer, as recommended by the enquiry officer; and

Now, therefore, keeping in view the recommendations of the enquiry officer, the enquiry initiated against Shri Davood Ahmad Shad, I/C SMS-III vide Govt. Order No. 36-JK(Agri) of 2021 dated 17.02.2021, is hereby closed.


