- v. That he shall not involve himself in any anti-national activities or subversive activities.
- vi. That he shall abide by the J&K (CCA) Rules, 1956.
- vii. That he shall abide circular instructions issued by GAD vide NO. 08-JK(GAD) of 2021 dated 13.02.2021.
