Subject:- Retirement Notification in favour of Shri Chowdhary Mohammad Iqbal, Director Agriculture Kashmir.

Notification

Whereas, Director Agriculture Kashmir vide letter No. Agri/Estt/Gaz-Noti/5370 dated 10.11.2021 forwarded list of officers retiring on superannuation from Government service in the year of 2022 which included Shri. Chowdhary Mohammad Iqbal, looking after the charge of post of Director, Agriculture Kashmir;

Whereas Shri. Chowdhary Mohammad Iqbal, was retiring from Government service with effect from 30.11.2022 based on his date of birth recorded in services records viz Service Book/ Certificate i.e.20.11.1962;

Whereas, on the basis of recommendations and as per the available records, the department notified the retirement of various officers of Agriculture Production (Gazetted) Service who retired in 2022 which includes the name Shri. Chowdhary Mohammad Iqbal, appearing at S. No. 32 in the retirement notification of Kashmir Division issued vide endorsement No. Agri-Gaz/122/2021 dated 07.12.2021;

Whereas, Government has granted extension in the services of Shri. Chowdhary Mohammad Iqbal for a period of one year vide Government Order No. 279-JK(APD) of 2022 dated 27.10.2022, therefore, after the extension, the officer shall now be due for retirement with effect from 30.11.2023; and

Whereas, Director Agriculture Kashmir vide letter No. Agri/Estt/Gaz/2022-23/4522 dated 24.11.2022 has requested for issuance of fresh retirement notification by including the extended period in services in favour of Shri. Choudhary Mohammad Iqbal, with effect from 30.11.2023 instead of 30.11.2022 in terms of extension in services given vide Government Order No. 279-JK (APD) of 2022 dated 27.10.2022.

Now, therefore, in terms of Article 226 (1) of Jammu and Kashmir Civil Services Regulations 1956, read with Government Order No. 279-JK (APD) of 2022 dated

27.10.2022, it is hereby notified that Shri. Chowdhary Mohammad Iqbal, presently looking after the charge of post of Director, Agriculture Kashmir shall be deemed to retire from Government Service with effect from 30.11.2023 (A/N) and the retirement notification issued earlier vide endorsement No. Agri-Gaz/122/2021 dated 07.12. 2021 shall be deemed to have been modified accordingly.
